RELEASE, WAIVER, and INDEMNITY AGREEMENT

In Consideration of being permitted to participate in the 2010 Capital Alumni Network (“CAN”) Soccer League (“League”) including, but not limited to, playing in or observing pre-season, regular-season and post-season League games, using League equipment, and/or being involved in the post-season League Tournament in any way, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned,

The Undersigned Hereby Releases, Waives, Discharges and Covenants Not to Sue CAN, its past, current or future officers, directors, administrators, agents, and assigns, the Tournament sponsor(s), National Park Service, DC Department of Parks and Rec, DC Sports and Entertainment Commission, DC Sports and Rec Association, their past, current or future officers, directors, administrators, agents and employees, all referees under contract, and/or the school, alumni association or local chapter on whose team I participate (hereinafter collectively referred to as “Releasees”) with CAN from all liability to the undersigned, my heirs, executors, assigns and administrators, for any loss or damage, and any claim or demands thereunder, on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the Releasees or otherwise, while the undersigned is in any way participating in the League, including, but not limited to playing in or observing League games, using League equipment, and/or being involved in the League in any way.

The Undersigned Hereby Agrees to Indemnify and Save and Hold Harmless the Releasees from any loss, liability, damage or cost they may incur due to the participation of the undersigned in the League, whether caused by the negligence of the Releasees or otherwise.

The Undersigned acknowledges that s/he is at least 21 years of age, or, if not 21 years of age, agrees that s/he will not consume alcoholic beverages at League games, related activities or events sponsored by the CAN, including but not limited to the Post-Season Tournament Party. The Undersigned Acknowledges that s/he Understands and Assumes Full Responsibility for and Risk of Bodily Injury, Death or Property Damage due to the negligence of Releasees or otherwise while playing in or observing League games, using League equipment, and/or being involved in the League in any way.

The Undersigned further expressly agrees that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The Undersigned Has Read, Understood and Voluntarily Signs the Release and Waiver of Liability and Indemnity Agreement, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
